Meet Conditions

1. General Conditions

- 1.1. The Cheshire County WP & SA Executive Committee reserves full powers over all County Championships and Meets. Promoters' responsibilities shall be delegated to the nominated representative at the event.
- 1.2. The events shall be held under Swim England Regulations, Technical Rules and the Relevant Fina/World Para Swimming rules.
- 1.3. The Promoter reserves the right to refuse admission to any competitor or spectator. Any matter not included in the conditions or meet information will be managed at the discretion of the Promoter.

2. Events

- 2.1. Individual Events:
 - 50m Backstroke, Butterfly, Breaststroke and Freestyle.
 - 100m Backstroke, Butterfly, Breaststroke, Freestyle, and Individual Medley.
 - 200m Freestyle and Individual Medley.
- 2.2. Individual events are available for both male and female competitors.
- 2.3. The schedule of events will be published in addition to these conditions.

3. Entries

- 3.1. Entries may only be accepted from competitors registered with a club affiliated to Cheshire County WP&SA.
- 3.2. Entries will be considered from competitors aged 9yrs, 10yrs, 11yrs and 12yrs only
- 3.3. Ages as at the 28th November 2021
- 3.4. Competitors are required to comply with all aspects of the entry process and pay the required fees.
- 3.5. Entries together with the appropriate fees must be received by the Competition Entries manager no later than 11:59pm on Saturday 30th October 2021.
- 3.6. Entry times must have been achieved at a Licensed or Level X Meet no earlier than 24th November 2019.
- 3.7. To enter this Meet competitors must have achieved the lower consideration entry time but not have exceeded the upper consideration entry time.
- 3.8. Submitted entry times will be used for seeding and rejection purposes. Updated or improved times will not be permitted.
- 3.9. The Entries Manager has the authority to adjust the number of entries accepted to ensure that the Meet runs in compliance with Swim England Licence requirements.
- 3.10. Entries will be accepted and rejected as necessary on a 'first come' basis
- 3.11. Entries not accepted will be automatically refunded in full

4. Meet Procedure

- 4.1. All events will be conducted on a Heat Declared Winner (HDW) basis
- 4.2. Competitors whose entries have been accepted will be expected to swim unless they have complied with the withdrawal process.
- 4.3. Should a swimmer withdraw from any event on the grounds of illness or injury they will not be eligible to compete in any other events in the Meet.

5. Para Swimmers

- 5.1. The conditions of the Cheshire County 16th Junior Level 3 Graded Meet shall apply to Para swimmers of swimmers holding a Certificate of Swimming Disability.
- 5.2. Para swimmers do not have to meet entry consideration times
- 5.3. Para Swimmers who hold a classification must state their classification at the time of entry
- 5.4. Competitors with a Certificate of Swimming Disability must produce their certificate to the Referee before they race.
- 5.5. Para competitors will be included in the main body of the schedule

6. Withdrawals

- 6.1. Withdrawals prior to the Day of Meet
 - By text to: 07960 392769 stating NAME, CLUB & EVENTS(S) that competitor is withdrawing from
- 6.2. Withdrawals on the Day of Meet
 - By text to: 07960 392769 stating NAME, CLUB AND EVENT(S) that competitor is withdrawing from
 - Or
 - filling in a withdrawal form available from the Competitors Stewards at the marshalling area.
- 6.3. Withdrawals must be made not later than the start of warm up for the session in which the event is competed.
- 6.4. Any competitor failing to swim who has not complied with the withdrawal procedure will not be eligible to compete in and further events at the Meet

7. Awards

- 7.1. Awards shall be made to the competitors placed first, second and third in the ages 9yrs, 10yrs, 11yrs and 12yrs provided they have not exceeded the upper level consideration time in the relevant age group
- 7.2. Speeding Tickets will be awarded to those swimmers who do exceed the upper consideration time.
- 7.3. There are no separate para/disability swimmer awards
- 7.4. Presentation ceremonies will not be held. Swimmers should collect their medals/
